

Municipal Services Agreement

- 1 The Mossel Bay Municipality has the right to govern local government affairs subject to national and provincial legislation. *The Municipality is constitutionally bound, within its financial and administrative capacity, to ensure the provision of services to the community in a sustainable manner.*
- 2 To enable the above the Municipality is entitled statutorily entitled to raise fees for services, surcharges and rates which the Consumer is statutory bound to pay promptly
- 3 This Municipal Services application constitutes an agreement between Mossel Bay Municipality hereinafter called the MUNICIPALITY, and the applicant(s), hereinafter called the CONSUMER.
- 4 This Municipal Services Agreement is subject to the MUNICIPALITY's By Laws, Credit Control and Debt Collection Policies, as amended from time to time.

- 5 The CONSUMER agrees;
 - 5.1 to accept notices and letter delivery by means of ordinary post, fax, email, hand delivery and/or registered post.
 - 5.2 to supply the MUNICIPALITY with address changes, immediately, in writing.
 - 5.3 to pay the account/s on or before the due date printed on the Statement.
 - 5.4 to pay a late payment fee if the payment date exceeds the due date.
 - 5.5 to pay interest on arrears at the permitted rate
 - 5.6 to pay the "Deposit" as determined into the MUNICIPALITY's Bank Account
 - 5.7 to maintain the "Deposit" balance equal to the average of the last 6 month's billing.
 - 5.8 to hereby authorise the MUNICIPALITY to increase the deposit, if said arrears are overdue for more than 30 days
 - 5.9 to protect the MUNICIPALITY's reticulation and metering equipment from unauthorised access and damage.
 - 5.10 to afford authorised personnel reasonable access to the property's reticulation and metering equipment.
 - 5.11 that the MUNICIPALITY may request a Credit Report from a Credit Bureau.
 - 5.12 that account behaviour and enforcement actions may be reported to the property owner and Credit Bureaus
 - 5.13 that where the municipal account is in arrears, a percentage as determined by Council, of the amount tendered to purchase prepaid electricity be allocated to the arrear account

- 6 The MUNICIPALITY agrees,
 - 6.1 to provide, install and own the utility reticulation and metering equipment supplied to the property.
 - 6.2 to speedily connect utility service supply upon receipt of the Connection Fee.
 - 6.3 to promptly restrict and/or discontinue utility service supply;
 - 6.3.1 if the property owner's permission is withdrawn in writing
 - 6.3.2 if any Municipal Account amount is in arrears.
 - 6.3.3 if the "Deposit" balance is less than the last 6 month's average billing.
 - 6.3.4 if tampering or unauthorised usage is identified.
 - 6.4 to promptly re-connect utility service supply after payment has been received.

- 7 The parties agree that,
 - 7.1 For all purposes arising from this agreement the CONSUMER and their surety(ies) (if any) hereby choose the physical address of the property as domicilium citandi et executandi.
 - 7.2 Both parties to this agreement consent to the jurisdiction of the Magistrate's Court irrespective thereof that the amount in dispute or the nature of the relief sought may exceed the jurisdiction of the Magistrate's Court Nothing contained herein shall invalidate the right of the MUNICIPALITY or its successor to proceed with action in any other court of competent jurisdiction.
 - 7.3 This agreement constitutes the whole agreement between the parties and no agreement, representation or warranties between the parties other than those set out herein are binding on the parties
 - 7.4 In the event of legal action being instituted against the CONSUMER at any time resultant from this agreement, the CONSUMER shall be held responsible for all legal expenses on the attorney and client scale. The CONSUMER shall further be liable for any tracing or collection fees incurred as well as for any cost, including stamp duties incurred by the MUNICIPALITY in an attempt to collect outstanding money on the account
 - 7.5 that delivery by ordinary post occurs 5 days after postage and delivery by fax and email occurs the next day
